Recovery In Action, Inc. - Recovery House Rules

Please initial all rules as you read and understand them.

RENT MUST BE PAID ON TIME EACH WEEK. NO ONE GETS BEHIND. YOU WILL NEED TO BE PAYING AHEAD FOR THE WEEK YOU'RE STAYING. PLAN AHEAD!		
No person who has been convicted in State or Federal court of the manufacture or a sex crime shall be permitted to reside in the house.		
Residents must live and sleep at the house for 14 days, follow all rules, and pay rent on time before overnight or weekend passes are allowed. You MUST let your house man know 24 hours in advance before staying out.		
You must attend 4 meetings per week and contact your sponsor 4 times per week. Houseman will make periodic calls to sponsors.		
No stealing or fighting will be tolerated. Do not touch other resident's things or eat someone else's food without permission.		
Rooms should be locked at all times when you are not in them. RIA IS NOT RESPONSIBLE FOR STOLEN OR LOST ITEMS.		
NO DRUGS OR ALCOHOL WILL BE TOLERATED. Breathalyzer and urine analysis will be requested if there is any question about your sobriety.		
Any over-the-counter drug that could possibly result in a failed UA needs to have a doctor's prescription or have been previously discussed with house liaison.		
No shoes from outside are to be worn in the house.		
Clean up after yourself and do your dishes <i>immediately</i> you're done eating. Finish your Laundry. NEVER leave for the next man.		
Make your bed and keep your room picked up at all times. Shower daily		
We recycle. All recyclables need to be placed in their appropriate places.		
All chores that you are assigned must be completed by your next weekly house meeting. Please let house guy know when you complete your chore		
No smoking in the house. Smoke outside and put cig butts in can.		
No visitors are allowed in rooms.		
There will be no overnight guests allowed at any times.		
No visitors after 10pm on weeknights and 12am on weekends.		
Quiet time will begin every night at 10pm.		
No heaters are allowed in rooms.		
Heavily soiled laundry items must be taken to a laundry mat and can not be washed in the house washer.		
Only the houseman is allowed to touch the thermostat.		
All complaints and concerns will be kept anonymous and should be taken to the houseman immediately.		
IF EVICTED, YOU ARE NOT ELIGIBBLE TO APPLY FOR HOSUING FOR 1 YEAR.

<ul style="list-style-type: none"> • To receive a deposit refund, tenant must be a resident of the house for 90 days and give 14 days' notice before leaving. • Failure to give notice will result in forfeited deposit. • No deposit will be returned in the case of alcohol or drug use. • No TVs allowed in bedrooms. • No extra furniture (beds, couches, dressers, etc.) allowed in bedrooms. Residents must use furniture supplied by RIA. 			
Responsibilities of Individual House Members			
<ul style="list-style-type: none"> • Resident must have legal employment to stay at house. • Resident must find a HOME GROUP and attend at least a minimum of 4 meetings per week. • Resident must have a SPONSOR and contact him at least 4 times a week. • Residents are expected to keep the house in clean condition and good repair. • Residents will periodically be expected to help during the neighborhood cleanup day or on work projects at one of the RIA houses. 			
House Rules and Eviction Policies			
<ul style="list-style-type: none"> • NO ALCOHOL OR DRUGS WILL BE TOLERATED. <ul style="list-style-type: none"> ○ A resident who is accused of such activity will be subjected to a drug or alcohol test. ○ Any resident who is found by reasonable doubt and suspicion to be under the influence of alcohol or drugs will be evicted immediately. • NO CRIMINAL ACTIVITY OR DISRUPTIVE BEHAVIOR WILL BE TOLERATED. <ul style="list-style-type: none"> ○ The house will evict tenants that who are engaging in any illegal activity or disruptive behavior. • No pets of any kind allowed in the house or on the premises. • Once weekly there shall be a house meeting of the houseman and the residents to talk about how there recovery program is going, what meetings they attend, what step they are on and how/if other residents can help out to achieve better recovery. • If any rent has not been paid on time, tenant can/will be evicted at the house meeting. • RIA reserves the right to change the rules, with notification to residents, at any time. • HOUSE MEMBERS WILL ABIDE BY ALL HOUSE RULES AT ALL TIMES.
